FSC Check is a tool to conduct a risk-based review of organizations and individuals that want to join or re-join the FSC system, thereby ensuring that their values are aligned with those of FSC, proactively using a tech-based solution. New applicants for certification and membership will be invited to go through FSC Check

Applicants for international membership are required to complete the FSC Check process as part of the application requirements.

- Upon receipt of the complete documents, we will send you an email to activate your account.
- Applicants should log in and fill in the online questionnaire.

Please note that once you have electronically submitted the information in FSC Check, the system can submit your application to the approval process.
